The foregoing right also includes the right of sale, broadcast, exhibition in promotion, advertising and trade. The Model agrees that the Images may be combined with other images, text and graphics, cropped, altered or modified. The Model acknowledges and agrees that the Model have consented to publication of Model's ethnicity(ies), but understand that other ethnicities may be associated with Images of the Model by the Photographer/Filmmaker and Assigns for descriptive purposes. The Model agrees that he/she has no rights to the Images, and all rights to the Images belong to the Photographer/Filmmaker and Assigns. The Model acknowledges and agrees that he/she has no further right to additional Consideration or accounting, and that he/she will make no further claim for any reason to Photographer/Filmmaker and Assigns. The Model acknowledges and agrees that this release is binding upon his/her heirs and assigns. The Model acknowledges and agrees that any further use of the Images will be without any further compensation to the Model. The Model renounces any right that he/she may has to inspect or approve the finished product and any advertising copy that may be used with connection with the Images. The Model consents to use of Model's name or any fictitious name, or any caption or printed material, in connection with the Images. The Model agrees that this release is irrevocable, worldwide and perpetual.
